## NATIONAL NEWS

### What the Shutdown Means for Troops, Retirees, Veterans, and Families

The clock ran out on the federal budget process at midnight Tuesday, shutting down the government for the first time since a 2018-19 funding lapse that lasted more than a month. While MOAA presses lawmakers to restore funding and to protect servicemember pay during the closure, you'll find details on how the shutdown affects all who serve and have served, and their families, below.

Currently Serving and Families Servicemembers will report to duty during the shutdown but won't be paid until funding is restored. Oct. 1 paychecks, drawn from funds budgeted for last fiscal year, were processed, but Oct. 15 checks won't be without funding or other legislation. [ACT NOW: Ask Your Lawmakers to Support the Pay Our Troops Act] The Pentagon's shutdown contingency plan outlines the full scope of ongoing operations, to include furloughs for hundreds of thousands of civilians. Some key details from the plan and other sources:

- Elective and routine medical procedures at military facilities may be canceled or postponed; contact your provider to confirm your appointment. The shutdown will not affect military families using TRICARE or TRICARE For Life benefits in the private sector.
- Military pharmacies will remain open, but hours may change. · Commissaries and exchanges will remain open, as will mess halls, gyms, and child care facilities "required for readiness." Military personnel may replace furloughed civilians to allow for continuation of other services deemed "necessary or appropriate."
- "Community and public outreach programs" such as concerts, military airshow appearances, and similar events that are not fully funded with non-appropriated funds (NAF) will be canceled or postponed.
- Death gratuity payments will continue. This is a change from the prior shutdown resulting from language in 2021 appropriations legislation.
- Department-run schools will remain in session, but extracurricular activities will be canceled unless paid for by non-appropriated funds. This could include sports practices and games, concerts, and similar events.
- Some training for servicemembers may be canceled or delayed if the instructor is a civilian. Contractor-led training may continue if the instructor is being paid from funds earmarked from the prior fiscal year.

- PCS moves and temporary duty travel will be delayed unless they involve supporting “exempted activity” or are deemed “essential to mission.” · Traditional National Guard drills may be canceled, though mobilized Guard and Reserve members, like their active duty counterparts, would report for duty.
- Active duty family members under the Federal Employees Dental and Vision Insurance Program (FEDVIP) will remain covered. Premiums will be deducted from retroactive pay when posted. [RELATED: Pentagon Takes Another Step Toward Commissary Privatization]

## Retirees and Survivors

- Armed services retirees, to include Coast Guard retirees, will continue to receive retiree pay during the funding lapse. Officers who retired from the U.S. Public Health Service or NOAA would not receive their next paycheck (Oct. 1 checks, covering pay from September, were processed). · Commissaries and exchanges will remain open.
- Elective and routine medical procedures at military facilities may be canceled or postponed; contact your provider to confirm your appointment. The shutdown will not affect retirees using TRICARE or TRICARE For Life benefits in the private sector.
- Military pharmacies will remain open, but hours may change.
- Survivor Benefit Plan payments will continue.
- Retirees and survivors covered under the Federal Employees Dental and Vision Insurance Program (FEDVIP) won't be affected. Federal employees whose FEDVIP premiums are deducted from their federal pay will retain coverage; their premiums will be deducted from retroactive pay when posted.

Veterans/VA The VA's contingency planning website contains full updates on the department's status during the funding lapse. Some key points:

- Health care facilities will remain open.
- Education, housing, disability, and other VA benefits will continue.
- Burials will continue at VA cemeteries, as will applications and related processing (except for pre-need burial applications). Grounds maintenance and headstone placement will be delayed.
- Transition and career counseling services will stop, and regional benefits offices will close.
- The primary call center (1-800-MyVA411), crisis line (988, press 1), and VA benefit hotline (1-800-827-1000) will remain open. GI bill and cemetery-applicant assistance lines will close. [FROM VA.GOV: Veterans Field Guide to Government Shutdown (PDF)]

## **VA: Benefits for ‘Legacy’ Caregivers Safe Until 2028**

Participants in the VA’s Program of Comprehensive Assistance for Family Caregivers (PCAFC) can remain enrolled through Sept. 30, 2028, as work continues on possible changes to eligibility criteria, the department announced in a Sept. 26 email.

The decision allows these caregivers to maintain access to a range of critical benefits, including a stipend some worried could be cut or withdrawn completely as new criteria took effect. The VA had pledged to keep legacy participants enrolled through Sept. 30, 2025; the new rule, published Sept. 29 in the Federal Register, adds three years to that extension.

“While the PCAFC’s future remains uncertain, MOAA is grateful to the VA for taking this step to provide some clarity and reassurance to legacy program participants,” said Cmdr. René Campos, USN (Ret), MOAA’s senior director of Government Relations. “We will remain involved with the VA’s efforts to establish new criteria as part of our ongoing work to provide those who care for our veterans with the resources and support they need and deserve.” PCAFC programs include respite care, education and training, mental health counseling, and some travel expenses. Primary family caregivers under the program qualify not just for a stipend, but may access health care coverage and some legal and financial services.

The recent extension covers all legacy participants, even those who “received a preliminary determination that they did not meet the [new] criteria or were determined eligible but at a reduced stipend amount,” according to the VA’s announcement. ### Past, Present, and Future of Caregiver Support

PCAFC came online in 2011 and was designed to support caregivers of post-9/11 veterans. Plans were made to expand the program in 2018 to caregivers “of eligible veterans who have a serious injury incurred or aggravated in the line of duty” prior to Sept. 11, 2001, according to the Federal Register rule update.

This move came with new eligibility criteria for all program participants, triggering enrollment issues, delays, court challenges, and a series of other problems that resulted in multiple deadline extensions.

Work on the new criteria restarted in earnest in 2022. MOAA and 11 other advocacy groups wrote to the White House in 2024 asking then-President Joe Biden to release the new criteria “as soon as possible,” as further delay “would only serve to prolong the strain that so many veterans and caregivers have felt while PCAFC continues to fall short of its intent and potential.” [RELATED: Online Account Changes Are Coming for VA, TRICARE Users. While the criteria come into focus, MOAA has continued its work on behalf of caregivers on multiple levels, including the halls of Congress. The Veteran Caregiver Reeducation, Reemployment, and Retirement (3R) Act, part of MOAA’s 2025 Advocacy in Action campaign, would improve and expand benefits offered to PCAFC participants, to include:

- Reimbursement for licensure fees and access to VA training modules for continuing education.
- Employment assistance for caregivers reentering the workforce.
- Retirement planning services, along with a study looking at the establishment of a retirement plan specifically for caregivers. You can help MOAA make its case by reaching out to your lawmakers and asking them to support this bipartisan legislation.

## **ID Update: Latest on Legacy Card Changeover**

Articles suggesting a Dec. 31 deadline for the replacement of paper-based military ID cards, including those with indefinite expiration dates, “are inaccurate,” according to a Defense Finance and Accounting Service (DFAS) news item released Sept. 24.

There is no requirement or deadline to replace the cards, DFAS stated in the item, which appeared in its quarterly retiree newsletter sent out in September.

The June DFAS newsletter initially contained an article announcing a Dec. 31 deadline. On July 10, after MOAA reached out to Pentagon public affairs officials to clarify the situation, DFAS updated the online version of that article to remove references to a deadline. Multiple social media posts, including some from installations and other official accounts, have cited the initial, inaccurate item and publicized the deadline. However, the legacy IDs “will all remain valid until DoD determines when those legacy paper-based cards will be terminated,” the most recent DFAS article states. “The Department intends to execute a positive communications plan formally announcing the termination well in advance of the actual termination date.”

Those with legacy ID cards should access their profile via the ID Card Office Online and ensure their contact information (email and regular mailing address) are up to date in advance of any such communication. While the cards will remain valid until their expiration date or until changeover details are announced, legacy cardholders “may replace those ID cards with a Next Generation USID card” at their convenience, according to the Common Access Card website. Are You Ready?] Legacy cardholders may be able to secure a replacement card online, or they can schedule an appointment to get a replacement card at their closest ID card office.
